Please submit your tender in English in accordance with the requirements stipulated in the procurement documents. Please note that this is an 'open procedure' and that there will therefore be no negotiations.

Technical bids are weighted at 70%, price bids at 30%. Fixed budget items for price bids specified in the competition documents are not included in the evaluation and weighting of the same. The following formula is used for weighting:

GIZ reserves the right to change the contract by taking up an option pursuant to Section 132 (2) no 1 German Act Against Restraints on Competition (GWB) (see Section 7 of the terms of reference.
